Regular Board Meeting Public Hearing on 2024-2025 Budget April 10,2024

At 6:00 pm, Mayor Lashua called the meeting to order, she opened the meeting with the pledge of allegiance. Trustees in attendance were Trustee A. Guardino, Trustee M. Hebert, Trustee E. Wood, and Trustee C. Basford. Also, in attendance was A. Spaman, DPW Supervisor; B. Bailey, HVFD Chief; T. Haynes and C. Fout, DANC.

Public Forum At 6:00pm Mayor Lashua opened the public hearing on the 2024-2025 budget, the hearing will be left open, and the meeting will continue in the event someone wants to comment.

HVFD Report Mr. Bailey gave a fire department report. The Board discussed the fire district. The towns have not made any decisions. Mr. Bailey left at 6:14.

Water/Sewer Mr. Fout gave a report on sewer and water operations. Mr. Haynes informed the Board the Village may qualify for hardship status in sewer debt and will be able to apply to refinance with EFC with no interest. There was a discussion on the Project. There will be a meeting with Ogdensburg on some changes that are needed to the storage tank. Mr. Haynes reviewed the I&I study agreement. They left at 6:54.

Whereas the Village submitted Consolidated Funding Application Number 127150 related to the completion of an Inflow and Infiltration Study during the 2023 application period. The Village's application was successful receiving a \$50,000 Engineering Planning Grant (EPG) from the NYS Environmental Facilities Corporation (EFC), and

Whereas, the Village desires to receive technical services from the Authority related to project management, grant administration, and engineer solicitation to complying with the requirements of the grant award, and Whereas, the Authority's level of effort to provide these services shall not exceed \$6,000.

Now, therefore, be it Resolved, the Village board authorizes the Mayor to execute the Inflow and Infiltration Study agreement with the Development Authority of the North Country for not to exceed amount of \$6,000.

Mayors Report Mayor Lashua informed the Board that Kevin Feuka will be applying for a Forward NY Grant. If he is interested the Village may look for other areas for grant opportunities. The Comprehensive Plan meeting went well, and the next one is scheduled to be May 1st. The Board looked over an updated employee evaluation.

RESOLUTION 24-034 HANDBOOK UPDATE

Resolution to make the following changes to the employee handbook:

2.2 Add: All permanent employees will be evaluated annually.

Article 13:

13.1 Remove: All Vacation Days will be credited to employees on June 1st of each year.

Add: Vacation time will be accrued as per this schedule and will be credited to employees biweekly. Only regular hours worked will accrue time.

13.3 Remove – at which time it must be used, or it will be lost.

Article 14:

Remove 14.1 All full-time employees shall be granted sixty-four (64) sick leave hours a year to be granted at the beginning of the budget year to be accumulated up to a total accumulation of eight hundred (800) hours. Sick time will be prorated for the first fiscal year.

Add 14.1 All full-time employees shall be granted sixty-four (64) sick leave hours per year to be accrued biweekly on an accumulative basis. Total accumulation will not exceed eight hundred (800) hours. Sick time will be prorated for the first year of employment.

RESOLUTION 24-035 FIXED TRASH INCREASE

Resolution to increase the fixed trash billing by \$2 a quarter beginning May 1st.

The Board went over the Budget and agreed with the revisions made to the tentative budget. No one from the public arrived to address the Board on the budget.

NOW, THEREFORE BE IT RESOLVED, that the preliminary budget as amended and revised and as hereinafter set forth is hereby adopted and that the amounts stated in the column title "Adopted 2024-25" hereby are appropriated for the objects and purposes specified and the salaries and wages stated in such budget shall be and are hereby fixed at the amounts shown therein effective June 1, 2024.

Streets/Sidewalks Mr. Spaman gave a report on the public works department. The Board discussed the safe streets work recommendations and a lower York Street sidewalk. There was a discussion on the sewer property. Mr. Spaman recommended putting the John Deere tractor out to bid along with attachments, Tr. Basford recommended looking into Auctions International.
